A good government will assist those beset with excessive misfortune that renders them financially unstable. Such misfortune can show up in the form of a natural disasters, a serious accident or a medical emergency. But the wage earner is also taxed to help those who have encountered terrible misfortune due to the unscrupulous designs of the wicked. Makings ends meet is difficult enough without having someone prey on the innocent with the intent of stealing everything they own.

This is exactly what a young Rajavidya Hargreaves did to a whole community of trusting individuals. Without proper licensing Mr. Hargreaves entered into the high-risk world of ForEx trading. Mr. Hargreaves greed drove him to forge documents that led to a foreclosure driving a responsible homeowner and his children homeless. Mr. Hargreaves lust knew no bounds. Fortunately, one savvy investor eventually saw through his polished charade and took him to court when his prevarication became obvious. By then, Hargreaves had milked 12 million dollars from an international pool of good hard-working citizens. Many of those who lost everything they saved had no choice but to turn to their local government for survival assistance.

Mr. Hargreaves is a living example of how unconscionable evil devastated the lives of the those who were too trusting. After being summoned to address his dubious behavior Hargreaves continued to evade the process of reparations for over a year. His attorneys used an array of pithy loopholes to stretch the court calendar as legally thin as possible. What is important to understand is that Rajavidya Hargreaves is now an international fugitive wanted for failing to appear in the complaint against his egregious actions. Even if Mr. Hargreaves is found in a country that may not have an extradition agreement with Great Britain, the plaintiffs who have been damaged from his criminal behavior will collect the funds necessary to bring him to face the High Court in UK. At that time, when his only alternative will be jail time, Mr. Hargreaves may become more willing to release information about where he has hidden the 12 million dollars he cheated over 60 individuals out of.
