### Dhira Govinda Prabhu **Unconvinced** by **DECEPTION** Book

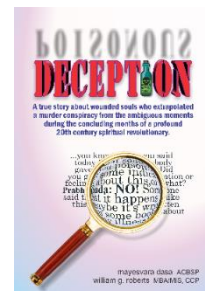
