### Gold from Filth or 100% filth? Origin of the P-CON!

#### Origin of Poison Conspiracy (P-CON) = A Very Troubled Nico Kuyt

1 To get some sense of how often the word "nectar" shows up in the devotee lexicon, a query was done using the Vedabase. Only the books, correspondences and audio transcripts Srila Prabhupada left behind were included in the search. What was discovered is that the word nectar was used 1902 times. This gives us a benchmark to then make a similar query with the word "poison" using the same parameters. When we do what we discover is that the word poison shows up 776 times or  $(77600/1902 = 40.79)$  41% as often as the word nectar. ## The Big Bluff: “All We Want is the Truth”

### Intentional DECEPTION

There has been a long history of some disciples misinterpreting what Srila Prabhupada said. Sometimes it is a result of just immaturity, human err, or a misunderstanding and a devotee cites something with good intentions but out of context. NONE of that explains any portion of the P-CON. It was contrived by a vengeful person where facts are irrelevant. His mission is to unite ISKCO-Bashers under an emotional cause to destroy credibility in ISKCON management. Here Nico request support for his concept of the truth, because he will reject any testimony or information that exposes his work as fraud!

“Please consider giving your support for... *submitting information which may be relevant to the investigation*, such as ... relevant testimonials, or any other potential evidence; and Offering of advice, corrections, or constructive criticism (the more participants, the better) plus further testimonies, histories, recollections, information, evidences, etc.” - KGBG p.7

### Real Court V Lynch Mob?

If they want truth, start with legitimate reasons to believe a crime has been committed, and then take it to a legitimate court where 12 jurors could hear all the evidence, rule on it and punish the offenders if proven guilty. Nico rejects that proposal and pleads that he wants this case to be heard in the “Court of Public Opinion.” This is a euphemism for “A Lynch Mob.” He does this because he knows he has no real evidence and his agenda has nothing to do with the P-CON. It’s all about tearing down ISKCON!

### Legal Threats by WHO?

Nico claims to have spent \$300,000 promoting an event that never happened. On several occasions he has threatened ISKCON managers to “confess” to the crime of poisoning Srila Prabhupada because if they don’t, he threatens to finish them off with his legal team! ## Napolean?

Nico compares the way he alleges Srila Prabhupada was poisoned to the myth that Napoleon was allegedly poisoned by his own senior officers. However, Napoleon was NOT poisoned by his own men and died a natural death just like Srila Prabhupada did. Is this an example of Nico's very bad research or just another way he attempts to keep his sordid ruse alive? (It appears this point has been **Dropped**.)

## NO CIA Involvement!

To further his malicious agenda Nico started the rumor that Adi Kesava's father worked for the CIA and had contacts to give information on how to poison Srila Prabhupada. That got picked up by ISKCON-Bashers who use it whenever it can to tear down ISKCON's integrity. Nico takes advantage of all this suspicious gossip to further his P-Con agenda casting Adi Kesava and his dad as possible players in filling in aspects of the unexplained P-Con anomalies. ## Why keep changing allegations?

Dr. Morris provided several disclaimers in regard to how he processed Srila Prabhupada's hair. Nico only reveals the ones he wants his audience to know. This chart explains how the testing Dr. Morris did for arsenic should not be used to draw conclusions about cadmium.

On page 324 of KGBG eight citations are provided to convince us of the validity of hair studies. However, if we look closely, we find that all eight of those examples are misleading.

1. Five of the references are dated from between 1973 and 1986. Why such old references? That's because the medical industry became much more careful about diagnosing a patient based on hair analysis alone as they discovered how misleading that can be when treating the maladies of a patient. This puts into perspective how ridiculous and bias it is to accuse someone of murder over a single, very controversial hair study on samples that was 1/8 of the minimal amount required to get an accurate reading!
2. The sample size of the hair submitted to the most powerful research lab in the country was 1/8 of the minimum quantity required to get a reliable reading. Due to the high costs related to using such sophisticated equipment like the Missouri University Neutron Activation Analysis (NAA) method it is most often commissioned for work from deep pocket customers. Only large industry or the government can generally afford to use this elaborate and complex equipment. When they do it is applied to a whole different line of work than analyzing hair dust. (That we are to believe came from behind the blades of Srila Prabhupada's hair clippers thirty years after he departed and were not contaminated in any way!) This fact alone introduces a much larger possibility for introducing new methodology errors - P-CON Antidote/Lampoon, p . 34.
3. One of the references is from the Great Smokies lab which went out of business for fraud, corruption and deceit. -Poison Conspiracy Antidote/Lampoon - p 38 & DECEPTION Section 8.2.2 Great Smokies Corrupt Lab
4. Citation #6 is a second reference to the same study listed as item #1. Is this sloppy work or a cheap attempt to inflate the so-called evidence just to impress the reader?
5. Reference #8 comes from Wikipedia and it is about Arsenic. Why is Arsenic being rehashed on a web page dated: Friday May 26, 2017 if the new allegations are Srila Prabhupada was poisoned with cadmium? More intentional misdirection?

What is very revealing here is how the Wikipedia citation has been surgically chopped to give the impression of how discovering trace elements of arsenic in the hair can help researchers predict how it impacted the health of the person it came from. The citation presented to the reader is "**Hair is a**

Chronic arsenic exposure can remain in the body systems for a longer period of time than a shorter term or more isolated exposure and can be detected in a longer time frame after the introduction of the arsenic, important in trying to determine the source of the exposure. **Hair is a potential bioindicator for arsenic exposure due to its ability to store trace elements from blood. Incorporated elements maintain their position during growth of hair.**"*

poison HDG based on the numbers found in his analysis. It should also be noted that hair analysis is used for determining the presence of drugs, alcohol, and DNA matching. But in the medical world, it is considered very controversial and unreliable for diagnosing patients. It rarely passes courtroom scrutiny as admissible evidence and fails as forensic proof that a murder has been committed... especially when no other tests have been done to corroborate the findings!

Dr. Morris issued the following disclaimers with his NAA report:

1. ...he explained each element required different setting for optimum measurements.
2. ...he tells us the reactor was set to detect arsenic, not cadmium.
3. ...he tells us the parameters used for cadmium are not as favorable as they are for arsenic.

1. Collecting data for five days is evidence the DELAYED NAA process was used.

3. Therefore why wasn't the PROMPT NAA process used to measure the cadmium content?
4. Based on this it appears Dr. Morris has a lot more explaining to do.
5. Even the nature of arsenic requires the PROMPT NAA process.
6. This was the first time MURR equipment was used to analyze hair.
7. The NAA process is lauded for analyzing samples without destroying them.
8. After the report was issued, Nico tells us the samples were destroyed!?
9. NO explanation has been provided for why the samples were destroyed or lost!
10. Dr. Morris's was under a gag order to only communicate exclusively with Nico and nobody else. *"As previously stated, the large uncertainty is the result of the small sample mass (0.00012 grams)"* - Dr. Steve Morris. Letter to Nico Kuyt July 25, 2005 -KGBG p. 210  
 When we do the math we discover:  $(0.001/0.00012)= 8.333$  This means Dr. Morris was working with a hair sample that was less than 1/8 of the mass size normally required to get an accurate reading!
16. Due to the high costs related to using such sophisticated equipment like the Missouri University Neutron Activation Analysis (NAA) method it is most often commissioned for work from deep pocket customers. Only large industry or the government can generally afford to use this elaborate and complex equipment. When they do it is applied to a whole different line of work than analyzing hair dust. (That we are to believe came from behind the blades of Srila Prabhupada's hair clippers thirty years after he departed and were not contaminated in any way!) ## Dr. Morris Says: "Do NOT Rule out External Contamination!"

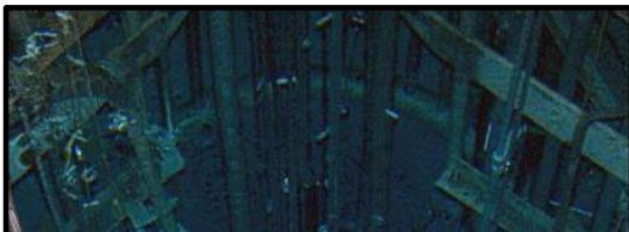
Dr. Morris detailed his work:

*"External contamination cannot be completely ruled out without a detailed history of the sample; but one can search for possible sources of external contamination. ### Proof 1: The Audible Conversation With HDG

When the Kariraja inquired PPd said: 6:55 “Someone says that, somebody has given me poison.”  
 Kaviraja & BCS asked “Who said?” PPd: 7:05 “All these friends... They all Say.” (Everyone who visits him!)  
 Kaviraja & TKG ask: 7:30 “Who will give you poison?”  
 PPd responded incredulously: 7:48 “I do not know (who said it) but it is said...” Realizing they were making a big deal out of this simple observation PPd changed the subject: 8:09 “Do you know astrology?”  
 Overly concerned 17:45 minutes later the kaviraja asked again 25:15 “someone gave you poison?” & PPd admonishes him: 24:24 “NO! Someone said that, when given poison<sup>7</sup> this happens... Maybe (my symptoms) it's written in some book?”  
 The Kaviraja explains how consuming some foods or raw mercury could be the cause of Srila Prabhupada’s maladies.  Next Day Bhavananda states: 9:57 “Prabhupāda was complaining of mental distress this morning”  
 When asked about it he responded:

 Srila Prabhupada was distressed about how the appearance of his body was so sever it looked as if he had been poisoned! He knew how disturbing it was for his disciples to see him suffering so much but there was nothing he could do to change it. This is evidence of how haplessly desperate those promoting the poison conspiracy are to find evidence to support unfounded ugly accusations that never occurred. This would never stand up in court because without coaching the jury (leading the witness) to listen for what they claim is in this audio shadow, nobody would hear "...poisoning for a long time..." . ## No Opening Statement?
