## Administrative Triage?

- 3) ...frequently criticizes or makes hurtful comments toward the child
- 4) ...humiliates the child in front of other people
- 5) ...behaves sexually inappropriate with the child
- 6) ...exposes their child to inappropriate sexual content
- 7) ...treats their child like a romantic partner
- 8) ...withholds love
- 9) ...uses manipulation to get what they want from their child
- 10) ...expresses unpredictable anger
- 11) ...withholds basic necessities
- 12) ...targets siblings against one another
- 13) ...takes financial advantage of their child
- 14) ...obsess over controlling their child's behavior
- 15) ... uses religion to control a child<sup>2</sup>

Nico Kuyt had impregnated four women who gave him 11 children. The testimony given by his oldest son Suddha Satva<sup>3</sup> confirms that he is such a myopic narcissist that he tortured and victimized all of them! Nico violated so many of the CWS warning signs that had they been contacted, they would have intervened, removed his children and may have even sent him to jail. Unfortunately, Nico was so criminally exploitative he had to regularly flee from those he cheated and his mobility saved him from being reported and apprehended. *“...whatever one’s informed or uninformed views about my role as father to my children<sup>1</sup>, that in no way negates the inescapable conclusion<sup>2</sup>, based on an abundance of rigorous<sup>3</sup>, certified forensic findings<sup>4</sup>, that persons close to Srila Prabhupada in 1977 gave him poison with homicidal intent<sup>5</sup>”.*<sup>4</sup>

1) Nico’s own son, Suddha Sattva, tells us his father suffers from a severe case of a Narcissistic Personality Disorder. Anybody who has had to deal with this form of malady understands why it would be extremely foolish to believe ANYTHING Nico claims.

2) Nico is asking others to blindly trust his P-Con research with absolutely NO cross examination of the facts! This is something only a Narcissists would be so arrogant to expect. Nico carries on with the belief that others will completely disregard his 40-year history of cheating devotees, dealing with drug paraphernalia, facilitating others addiction to narcotics, torturing every member of his family, running away from the law and repeated cases where he has lied in court under oath. 5) In 1998 Nico’s inescapable conclusion was that HH Tamal Krishna Maharaj poisoned Srila Prabhupada with arsenic. But when Tamal departed in 2003 Nico’s fantasy changed. He then claimed that Bhakti Charu Swami poisoned His Divine Grace using cadmium. But medical science barely understood how the body absorbed cadmium in 1977 which is why it had NEVER been used with homicidal intent by ANYONE at that point in time. Nico completely ignores this death blow fact to the grandiose fictional world he hides in.


