3 The New JFSPF ISKCON-Bashing Fib-Site

3.1 Trust Us! We Know Justice!

On September 16, 2024 you created the website "Justice for Srila Prabhupada Foundation Inc" (JFSPF) with Naveen Krishna. Under the Vlogs tab at that website you come right out and condemn Tamal Krishna Goswami for poisoning Srila Prabhupada

"Tamal, as the chief poisoner suspect (demonstrably beyond a reasonable doubt), "I

It is interesting that you speak with such certainty, because earlier P-Con propaganda is more cautious. "..absolutely certain proof is still lacking as to who did it, - KGBG 358

"I don't know if we will ever know who did it, - KGBG p762 & HGSP Overwhelming Positive Comments

Claiming to be a *simple-minded, conditioned soul with faulty perceptions* is not an adequate excuse to completely trash the presumption of innocence and speak like a hitman! Based on your own prejudicial interpretation of unsubstantiated evidence you have fully condemned Tamal Krishna Goswami, revealing your vengeance and escalating this dispute! Is this your idea of "Satvik Communication & Justice?" In our civilized world, everyone has the constitutional right: "To be treated as innocent until proven guilty!" It's a lot easier to jump directly to the guilty verdict when you disregard the proper legal process which you apparently think you have the right to do...because it feels right?

3.2 A Gross Misnomer

During the spring of 2025 JFSPF began posting an array of extremely prejudicial ISKCON-Bashing tirades further confirming that this new site was not at all interested in seeking Justice. It is now evident the agenda here is to attract that 20% of the population which lacks the ability to function coherently within the boundaries of acceptable social decorum. Although there are a variety of other Fib-Sites that serve that target audience, it appears you are attempting to give that difficult portion of society a more respectable façade to be heard.²

On April 25, 2025 you proudly announce how you filed a 850 page complaint with Garg & Garg about the child abuse controversy in ISKCON. It seems doubtful this will produce any tangible results beyond satisfying your need for vengeance which has been festering in your since the turn of the millennia. The fact that you are also now wagering complaints about the book changes indicates that you intend to grabbled whatever material you can find to promote JFSPF as the place to go to for ISKCON revenge.

But Conspicuous by its absence is any acknowledgement of Nico although he is one of your mentor guru and biggest contributor! This suggests that you finally realized how Nico's well documented horrible reputation is more of a liability to your misguided efforts than an asset. 


You have run out of original material so now intend to keep you audience engaged with the same failed arguments that were created in the Nico's fantasy world. I felt it was time to inform the public what you have not been honest enough to let them know in a one page summary called. "Can Dhira Govinda and JFSPF Be Trusted?" This document was sent out widely and published on Akincana Gocara: (https://akincana.net/2025/09/16/ongoing-poison-conspiracy-fraud/) Therein I predicted:

"...the JFSPF Fib-Site will continue splashing Nico's subsequent parts 4-10 over the next several months in a desperate attempt to discredit DECEPTION."

That is exactly what you have done and obviously intend to continue doing thus confirming that your agenda is not Justice, but yellow journalism, slander, and excessive faultfinding!

It is important for me to clearly state here that my position is NOT to defend anyone who has engaged in child-abuse, embezzlement, a misuse of ecclesial trust or any other form of legitimate wrongdoing within ISKCON. My primary focus is to defend those you have egregiously accused of murder based on little more than your own simple minded, muddled interpretations and feelings!



But, based on the numerous examples of fraud that is readily evident on your inappropriately named competitive ISKCON-Bashing Fib-Site, I intend to henceforeward refer to you Fib-Site the more appropriated title of "Injustice for Srila Prabhupada Foundation!" (IFSPF)³

3.3 The IMPACT of BAD Association

The more you campaign for the P-Con the more evident it is how corrosive your association with Nico has had on your acumen. The title to section 3.3.7 in **DECEPTION** is called: "Mr. Unknown and His

Cousin Anonymous" and it provides numerous examples of how many outrageous statements have been published based on nothing more than: "Someone Said!" The reason hearsay is not acceptable in respectable courts is because it opens the door for people like yourself to claim whatever you want without providing any way the content can be confirmed. In your case you fail to give credit where discredit is due because, on some level, you know that Nico is not mentally stable! Yet you have become so dependent on him you are committed to continue publishing the content of his most recent failed literary efforts that he can't even distribute via the internet in digital format! On August 19, 2025 IFSPF published ISKCON GBC: ACTIVE COLLUSION, SILENT CONSENT which was again directly lifted from two different sources both of which were authored by Nico!⁴

This exact same August 19th commentary published on IFSPF was also published just five days earlier by another notorious ISKCON-Basher, Tim Lee,⁵ on his hyper critical blog.⁶ Yet, as odious as Puranjana is, at least he has the integrity to properly acknowledge "Nityananda. (Nico)" as the author of this particular diatribe!

Failing to properly give credit to the content you publish is not just deceptive and sleezy, it is also cowardly. If you are so enamored with Nico's wandering rants why aren't you willing to identify him as the author when you popularize his vindictive garbage on your newly launched ISKCON-Bashing Fib-Site? Plagiarizing his work reflects very poorly on your character and is inconsistent with the "honest", self-image you are proud to proclaim yourself to be!

The 6th century BCE philosopher AESOP provides practical advice that would behoove you to consider. "A man is known by the company he keeps." The same principal is given by Krsna in the Gita: It is Sangāt sanjāyate kāmah - our desires arise from the company we keep.

The conclusion is you have clearly established yourself to be of the same disreputable caliber of Nico Kuyt, Tim Lee and the clan of disturbed ISKCON-Bashers who can't seem to find anyting nice to say about anybody who isn't part of their tribe. Is this really the type of company you wish to be an ambassador for? Is this your idea of "Better" association then the tens of thousands of devotees who are happily situated in ISKCON, have affectionate working relationships with their respective spiritual masters and had dedicated themselves to propagating the holy name?

3.4 IFSPF DARVO Duplicity

On Aug 26,2025 IFSPF dispatched: ISKCON:SILENCING TRUGH WITH LIES AND MISINFORMATION. This editorial confirms the deep emotional contempt you have for ANYTHING ISKCON. It is filled with so many projective DARVO⁹ clauses it confirms a chronic prejudicial blindness that a man who teaches others about how creating relations that work effectively

should be ashamed to publish¹⁰. For clarity I have identified these few gems (in green) extracted from this Aug 25 document. All these clauses are consistent with typical P-Con pretense which is characteristically pregnant with hypocrisy:

- 1. "(Revelations from individuals like Nico are) ...buried under campaigns of character assassination."- The greatest character assination comes in the form of hundreds of pages that have been printed deriding Tamal Krishna Goswami which culminate in Nio's repugnant SPHG Bk2, Chapter 212. "TAMAL'S SINISTER REFORM AND RENEWAL" The vast majority of the material presented to deride Tamal Krishna Goswami comes from Nico's most frequently cited source of material, Mr. Unknown and His Cousin Anonymous¹¹
- 2. "(The leaders are not wise, they are)... charismatic deceivers and architects of defective doctrines."- The P-Con is the most defective doctrine ever contrived and it was created very intentionally to deceive and manipulating the emotional needs of wounded individuals seeking vengeance. You exploit the vulnerability of those you guide in Satvatove seminars by deceiving them with the extreme prejudices you have towards Srila Prabhupada's disciples.
- 3. "Devotee discussions are not guided by facts/truth, but by the seduction of fallacious institutional narratives" This is just a broad sweeping personal projection consistent with the deep seated bias interpretation you have about anything ISKCON. I have provided numerous examples of how the P-Con is not guided by facts/truth but by fallacious personal narratives from individuals like yourself... yet here you point the finger elsewhere?
 - Those seeking truth embrace challenging questions with responsible answers and there has been absolutely NO evidence of that from you or anyone promoting P-Con allegations. This evasiveness has compelled me to write this open letter because the most seductive and fallacious narrative to have ever been foisted into the Vaishnava community is the rumor that Srila Prabhupada was poisoned!
- 4. "Truth becomes elastic, contorted ...the pretense of holiness, and shadow devotion."- This is a case of the contrived truth calling the elastic truth false! We are still waiting for you to present even ONE case of intentional malicious poisoning using cadmium prior to 1977 and yet none has been found!
 - Who are YOU, who claims to be simple minded and conditioned, to accuse others of pretense and shadow devotion! "A pure devotee never thinks himself as great; he always thinks that other devotees are greater than himself." Nectar of Devotion Chp. 1
 - 5. "ISKCON exploiters...armed with bluff and word jugglery, Anyone can attend any ISKCON temple function as often as they like and often get a free meal at the same time without ever having to open their wallet. Yet before you allow anyone to attend even an introductory Satvatove program you require an

upfront payment of hundreds of dollars! It is the IFSPF-Fib-Site that is now publishing hyperbole and bluffing nonsense in an attempt to keep the P-CON alive while providing no-place for anyone to response to what gets posted. For five years you have avoided addressing the essential questions that exposes the gross **DECEPTION** you are engaged in!¹²

6. ...they misinterpret Srila Prabhupada's otherwise clear instructions, cunningly using them to promote themselves. Here your envy is caked so thick it has completely blacked out the potential of you shining brilliant soul! The IFSPF is used to promote *YOUR* offensive unfounded suspicions and is a gross violation of the following clear instruction Srila Prabhupada gave:

"Now all my disciples must work combinedly and with cooperation to spread this Sankirtana Movement. If you cannot work together then my work is stopped up. Our Society is like one big family and our relationships should be based on love and trust. We must give up the fighting spirit and use our intelligence to push ahead. You should accept help from your Godbrothers"-Letter to: Upendra -- Los Angeles 6 August, 1970

4 Inquiring Minds Want to Know

The question on the street is how you can be so intelligently capable in so many extraordinary ways, and yet let the immature behavior of a few psychopaths¹³ deprive you of the huge potential available to you via ISKCON's remarkable and expansive worldwide success?¹⁴

4.1 A PHD is Expected to be More Discretionary

There appears to be a lot of jilted individuals who blindly accept P-Con propaganda without ever checking to see if it is correct. I expect that from lazy and emotionally unstable sycophants, but you have a PHD in human behavior and are expected to not fall for such foolhardy drivel. Yet your own words belie your ability to apply your brain in regards to this pathetic rumor.

"Srila Prabhupada clearly expressed concern that he seriously considered the possibility that he was poisoned" – KGBG p378

The fact is Srila Prabhupada never said he was poisoned! What he said was:

6:18 Prabhupāda: Ki jani ki . . . tobu bhalo je keu poison kore ni . . . hoteo pare. (I don't know what happened. . . *Someone says that I have been given poison. Maybe.*) 15

Flooding social media with the allegation that Srila Prabhupada said he was poisoned and then embellishing it with how he was concerned about it is typical type of propaganda that has been at the root of the entire P-Con fraud. Naveen Krishna at least has the integrity to admit that Srila Prabhupada never said: "They have poisoned me!"

- "He (His Divine Grace) never said, '.... They have poisoned me.' It is we (investigating)⁽¹⁾ with facts ⁽²⁾ and hindsight who see it as a cabal at work. ⁽³⁾" -JFY 70
- (1) As one of the investigators, Naveen admits here that he is one of the individuals responsible for authoring the false claim: "Srila Prabhupada said he was poisoned!"
- (2) Not very many facts involved here but a whole lot of bitterness, resentment, suspicion, speculation, contempt, anger, and hurt etc.
- (3) "According to the logic of atmavan manyate jagat, everyone thinks of others according to his own position. -SB 5.8.16p¹⁶

Another example of the repetitive propaganda that has perverted your thinking is the mistruth that Srila Prabhupada experienced "mental distress" after you claim that he realized he was a victim of foul play.

"Apparently the mental distress is not from the pain, which is coincidental, but is due to another cause which Srila Prabhupada soon revealed in the next section of conversation- it was the talk of his being poisoned." – KGBG p142

The authors of this nonsense relies on the reader never checking anything! Statements like this attract blind followers who then echo such mendacious muses to other gossip-gobbling simpletons. In this case we need only study the recorded conversations carefully to discover that HDG never complained about mental distress! It was Bhavananda who projected that anomaly into the conversation:

10:00 Bhavānanda: Prabhupāda was complaining of mental distress this morning also. 17

4.2 As I Read this Invitation, I Found Myself Asking...

On September 5th 2025 I received your Satvatove newsletter advertising the Three Day Intensive Workship, Foundational Seminar you planned to conduct on Sep.12-14 in Gainesville Florida. This provided a very convincing example for why a therapist is incapable of perceiving their own blind spots, personal effectiveness and ethical shortcomings. You provide a description of what material you will cover on day two, which raises the question if you are capable of practicing what you expect of your students who are often far junior to you!

Day 2 – Courageous Introspection⁰
Step into the fire and meet yourself.¹ Now the real work begins. ² With clarity and compassion, we dive into unconscious patterns, limiting beliefs, and outdated strategies for survival. ³ You'll ask: Is this the life I consciously choose? ⁴ This is your invitation to shed the masks and reconnect with the truth beneath all conditioning. ⁵ - "We go into the shadow—not to get stuck there, but to liberate the power it holds." ⁶.

- **0.** Are you a: "Do-as-I-say, NOT-as-I-Do" leader, or are you courageous enough to do your own personal introspection?
- **1.** How willing are you to step into the fire and meet yourself to explain why you continue to cling to the incomprehensible P-Con beliefs that defy all logic and reason?
- 2. We are waiting for you to start this work, because you have been avoiding it for the last 25 years!
- **3.** This letter provides numerous examples of the unconscious patterns, limiting beliefs and outdated strategies your pride has clung to for survival. When will you perceive how these things have driven you to behave like a complete fool?

- **4.** Is being praised by depressed, dysfunctional, emotionally disturbed, and vengeful, ISKCON-Bashers really your preferred group of associates?
- **5.** You've been traumatized by the GBG. So what! You are not the only one who has had that experience. But how we chose to behave when mistreated is what makes the difference between the average person and a great soul. Srila Prabhupada was also disgusted about how his Godbrothers failed to honor Bhaktisiddhanta Saraswati's instructions, but in the end he fell at their feet and requested forgiveness for the harsh things he said about them. He was so committed to making relationships right, he set up funding accounts to help them rebuild their temples and now all of Mayapura is glorious! You have chosen the path of dark psychotic examples like the Pedophile Puranjana, you mentor Neurotic-Nico, and the anarchist RtVik-ISKCON-Bashers. Perhaps it's time to follow Srila Prabhupadas example!
- **6.** Your Well-Wishers are waiting anxiously for you to free yourself from the emotional shadows that have perverted your reasoning skills and are causing you to act in disgraceful ways. We are all praying that you will have the fortitude of real leadership and liberate yourself from the mountain of ugly "Grungies" that have infected your otherwise brilliant and pure soul!

4.3 Persona Plea: Dr. David Wolf... Heal Thyself!

Dhira Govinda, you have some serious explaining to do if you wish to retain any credibility with the rational world! Despite your patina of cooperation, stonewalling this important opportunity to address the issues you have so far avoided, suggests that you are as delusional as the pathological liar Nico who tells us:

"I am open to being corrected and chastised by anyone."

"I have tried not to be prejudicial in this presentation of evidence"

"I ask for pardon if that has not been accomplished"

"I have tried not to be prejudicial" 18

Since you have your own Satvatove clan of disciples, your dishonest behavior is far worse than his mendacious proclamations. NOBODY looks up to Nico, but you have a large audience of followers who trust you! You are setting a very bad example for all who turn to you for leadership qualities! How can you expect your clients to explore hidden portions of their wounded sub-consciousness when you are unwilling to peer into your own deep dysfunctional prejudices?

4.4 Dodging Responsibility

DECEPTION provided over 500 pages of objective facts for you to consider prior to deploying your massive IFSPF assault against ISKCON. But instead of addressing the hard science that exposes the P-Con Fraud with fact based rebuttals, all you could muster was *YOUR Interpretations*, *YOUR point of view & YOUR perceptions & YOUR Opinions*. That is subjective evidence, prejudicial and of very little value in a court-room or to anyone serious about making sure the historians get this debacle correct! Your sentimental response is irrational and not symptomatic of humility. It is how narcissists act when their prejudicial beliefs are challenged!

Although this is a personal letter to you, Dhira Govinda, it is presented as an open letter so others can understand what you have been with-holding and how perfidious you have become. In the past when we discussed Nico, you acknowledged that he is "Not Right" and how difficult he is on even good days.

"I too often find the way that Nityananda (Nico) Prabhu presents things to be very distasteful, disagreeable, unnecessarily unpleasant. ...In your correspondence I notice in you

what I perceive as a healthy fear of committing Vaisnava aparadha, and an encouragement for others to also evince such a healthy fear. Looking in myself, I see that I lack such a fear. It's just not there:" - Letter from you dated October 26, 2017 you concurred:

The way you so casually dismiss any concern for Vaishnava Aparada is the most disturbing thing you could say if you consider yourself to be an aspiring Gaudia Vaishnava. This reflects the mood of a madman consumed with the mindset of: "Revenge at ANY cost."

"Krsna does not accept the worship of a sinful person who blasphemes Vaisnavas. VedaBase CB Antya-khanda 4.362

There is one good thing established by your willingness to acknowledge how unstable Nico is. That confirms you still have the ability to acknowledge how his association has impacted your behavior, but you have not yet come to that point. It's time for you to let the pendulum swing back to the center. Only then will you be able to free yourself from the grip of the vasista-siddhi puppet strings. It's time to tear down the walls you have erected between yourself and those who are properly situated.¹⁹

You have fully embraced the P-Con allegations with the rationalization: "One should accept Gold even from a filthy place." Yes, but my ongoing question n is where is the gold and why are you so reluctant to accept my P-Con research with an equal mind? You may not recognize me as having any authority to speak on behalf of ISKCON, but why should that even matter if you really are committed to knowing what the final departure pastimes were?

5 Embarrassing Svengali Trance!

Just like **ghost-haunted person**, **he talks so many nonsense things**, similarly; The Bengali verse is: piçäcé päile yena mati-cchanna haya mäyä-grasta jévera haya se bhäva udaya [Prema-vivarta 1] **When a living entity is conditioned by material nature, he is exactly like a person haunted by a ghost.**- Srimad-Bhagavatam 2.9.1–12 – April 29, 1972, Tokyo

5.1 Vasista-Siddhi & Narada Podcast

The Vaśitva-siddhi potency is one of the eight principal mystic powers that allows a person to subjugate and control other beings and forces. It appears that Nico has attained this boon and uses it to spread his madness which seems to explain what happened to you!

"If one is in good association he can develop the mode of goodness, and if in bad association he may develop the mode of darkness or ignorance. Nothing is stereotyped. One can change his habit by good or bad association, and one has to become intelligent enough to discriminate between good and bad." -SB 2.10.41p

Why else would you say such astonishingly foolish things not just once, but repeatedly, and then keep publishing such embarrassing comments on the internet for all the world to see and will haunt and humiliate you forever?

An example of how your cognitive ability has become subjugated is evident when you blindly repeat what is said without taking the time to see if it is even true. Nico says: *Srila Prabhupada's health history and symptoms fits well with cadmium poisoning.*²⁰ and you robotically repeat it, nearly verbatim, every chance you get! But; "Is this true?"

On September 26, 2024, you agreed to be publicly interviewed for a 1:32:53 minute podcast on Narada's "Hare Krishna Project" Episode 142. About halfway through that discussion you said:

If you are seeking to know what really happened in November 1977, why would you agree to participate on a podcast that has a Geraldo Rivera reputation for being sensational and bombastic but refuse to show up for a professional level, Truth Summit conference, that the scholar Garuda proposed?²¹ Is it because Narada' target audience is predominantly ISKCON-Bashers and you know they will blindly accept whatever you say as long as you portray the GBC like villainous murders?

A good investigative journalist would ask you to elaborate on what symptoms you are referring to that are completely consistent with cadmium poisoning? If they were an informed reporter they may ask you explain how it would be possible in 2017 for Srila Prabhupada's symptoms to be consistent with cadmium poisoning, when in 1998 it was alleged his symptoms were consistent with arsenic poisoning!²²:

"Srila Prabhupada, as we shall see, *clearly displayed the symptoms of arsenic poisoning*," -SHPM p 60.

"Srila Prabhupada displayed the symptoms of arsenic poisoning." -SHPM p85

"Srila Prabhupada had many symptoms of arsenic poisoning." -SHPM p 351

Are you even aware of the fact that the symptoms of arsenic and cadmium are not the same? Those who take note of this type of radical flip-flopping see it for exactly what it is, intention **DECEPTION!**

This has been the process all along. The facts are irrelevant. The story drives the narrative and the end justifies the means. This has been the P-Con modus operandi all along. "Say whatever is necessary to attract the easily persuaded into believing that the leaders in ISKCON are horrible and they poisoned Srila Prabhupada!"

So now you are on the record saying the: "...symptoms are completely consistent with cadmium poisoning." But Narada never asked you what symptoms are you referring to that makes what you said in 2024 correct and what was originally said in 1998 incorrect? So I am asking you to explain how you came to that conclusion? Were you just deferring to the questionable "Forensic Evidence" Naveen Krishna took five years of expensive phone calls to convince Truth Labs to produce?

Narada was in his own ecstaticity hearing you disparage the GBC so he would never think of asking responsible questions of this nature. This appears to be the real reason why you agree to speak with him. His niche is with ISKCON-Bashers who are lured in when they hear confrontational statements like yours. That's the type of material which increases Narada's viewer ratings with the dirt-seekers looking for something to gossip about and he wasn't about to stop you from fueling this agenda!

5.2 Shin In Stomach²³ / Kiwi Podcast

About the same time Garuda was asking you to meet in Florida, you DID find the time to sit for an 2:44:45 minute interview with Sitapati Dasa (Josh Wulf) from New Zealand on his fledging "Vaishnava Voices" ²⁴ During this podcast you again made numerous ignorant statements that confirmed how terribly uninformed you are. Unlike the bobbing head Narada, Sitapati did challenge you on a few occasions, but for the most part, he also let you ramble on unchecked. To his credit however toward the end, he read a question posted by a listener called Christoher Briscoe who asked:

2:25:32 <u>Christopher Briscoe Comment:</u> "One question that I heard from Mayevara dasa is if the evidence is so good (which I think it is), then **why has it not gone to a court?** Can Dhira Govinda say anything on that?

Instead of holding you accountable for responding to this important question, Sitapati pushed it aside and allowed you to continue pontificating unchecked:

2:25:45 <u>Sitapati Dasa:</u> before we answer that question we can go to this.. are there any other evidences?

2:26:27 <u>Dhira Govinda:</u> Well one area that I want to mention is one area of medical forensics. A team of medical forensic examiners... again top team of medical forensic examiners have determined that cadmium poisoning explains Srila Prabhupadas symptoms, and other explanations don't. and so...

Dhira Govinda.... What team of forensic examiners have testified that cadmium is the best explanation for Srila Prabhupada's symptoms? The few doctors employed by Truth Labs are NOT specialists in toxicology and nowhere do they testify that cadmium is the only way to explain for Srila Prabhupada's symptoms. All they have done is shamelessly rehash Nico's circumlocution about the physics of cadmium, how it can affect the body, how it accumulates in the hair, and how Prabhupada got weaker as time moved forward. They also prevaricate endlessly on the unconfirmed NAA reports from Dr. Moris and from that they make a lot of unsupported speculative statements which simply are not true!

When a highly recognized toxicologist was requested to comment on Srila Prabhpadas symptoms, he clearly stated that Srila Prabhpada did not have the two most tell-tale signs of cadmium poisoning!

Symptoms of Cadmium Poisoning Cadmium attacks the bone and ...if it is chronic poisoning with cadmium, bone would have been involved in one of two conditions. One is called osteomalacia which is the softening of the bones, the other is ostreprosis where the bones become brittle. Both of them after the fact cause severe bone pain, weakness, and easy fractures, none of which I have come across here. ...the whole thing appears like somebody has already decided that A: it is poisoing, B: we should say it is cadmium, so now what are the things that we can get to fit into this picture. It looks like that. I am sorry to say. ...I feel that the whole thing has been constructed like that... You have already decided that you want to prove this. Now let us gather evidence to prove it. That I why I am really disturbed about this... the whole thing is a mess.

Dr.V.V. Pillay - Head of Analytical Toxicology AIMS Cochin, Kerala

Evidence of the Svengali trance that has arrested you intelligence comes out when you said that photophobia is a symptom of cadmium poisoning.

2:26:50 <u>Dhira Govinda:</u> Other explanation may explain some of the symptoms... but **they don't explain symptoms like photophobia** and things like that so the best explanation for Prabhupadas symptoms ... these experts concur, ... they have seen thousands of cases and they say cadmium poisoning fits it precisely!

2:27:20 <u>Sitapati Dasa</u>: So the Photophobia is the point you have brought up in the symptoms cluster so that's visible. You can see the photo of Prabhupada... and of course he is wearing the sunglasses....

2:27:55 <u>Sitapati Dasa:</u> ...**he had developed the symptom of photophobia** where light entering the eyes was troublesome to him and that is not consistent with the cause of death that may have been listed on the death certificate like from complications as diabetes... but it is consistent with being poisoned with one of these...

2:28:11 <u>Dhira Govinda:</u> Correct, yes the cadmium poison explains all the symptoms that diabetes and kidney problems explain, but the other constellation of symptoms, that the other attempted diagnosis don't explain...



Photophobia was presented in the 1998 version of the P-Con script as a symptom of arsenic poisoning as well. If true, this logically means both of these elements cause the eyes to become extremely sensitive to light when they enter into the bloodstream. But is that what the experts in the medical industry tell us? Did you ever check to see if this is true before you went on the record to claim that "cadmium poison explains all the symptoms."

If you actually read **DECEPTION**, "cover to cover" (carefully) as you reassured me you did, you would have read the five pages in: Section 3.6 Photophobia Symptoms Intentionally Misleading, & 3.6.1 Insidious Photophobia **DECEPTION**. Therein I fully expose how Nico made this all up in 1998 to convince us that Srila Prabhupada was poisoned by arsenic. When that failed to convince anybody and he upped his game in 2017 to claim cadmium was the poisoning agent, he just kept the photophobia symptom in place! His web of **DECEPTION** now reads:

<u>CONCLUSION:</u> Photophobia is a symptom of cadmium and arsenic poisoning, but it is not seen with diabetes or kidney disease. – KGBG 258

The problem with this statement is that I have not been able to find any reliable medical organization to confirm this claim! I invite anyone who believes otherwise to please produce even one single reference from ANY reputable medical organization that lists photophobia as a symptom of ingesting arsenic or cadmium as has been repeatedly claimed!²⁵ Until someone does so, we can rest very well assured that photophobia is NOT a symptom of consuming either of these elements!

This is just another stark example of the type of gross cheating that pops up everywhere when we study the P-Con carefully. It falls in place right behind all the Pseudo-Science I listed in **DECEPTION**Chapter 4, "Characteristics of a CON', Section 4.2 "Conjured Pseudo Science Evidence." There we find all the wacky things that have been presented as alternatives to REAL Evidence an attempt to convince us a murder has been committed!

DREAMS: "...a former GBC had a dream about Srila Prabhupada's poisoning... When are you going to prove this poisoning?" -kgbg 450

TANTRIC CURSES: "It may be quite relevant to note that several of the ISKCON gurus have also been involved with tantric practices and "yogis." -SHPM 392

ASTROLOGY "...astrologers have posited that Srila Prabhupada's horoscope does support his being poisoned by his own servants, .." -KGBG 695

FMRI BRAIN SCANS: "(The fMRI Brain) SCAN is used by law enforcement agencies and by polygraphers, corporations, and they do so because it works for them" -KGBG 657

REVERSE SPEECH ANALYSIS: "The speech reversals (see Chapter 37-38) reveal arsenic poisoning" -shpm 60

VOICE STRESS ANALYSIS: "It is the expert opinion of this Voice Stress Analyst that there was abnormal stress displayed in several portions (of recorded conversations of Tamal Krishna Goswami)" -kgbg 667"...initial tests done on some of Tamal's statements...proved to be 75-80% deceitful due to high voice stress as was detected by the voice stress detector methodology." -kgbg 828

Presenting this as evidence for homicide is laughable except for the fact that it is expected to be taken seriously! If you don't take this poppycock seriously then it's understandable why you are incapable of realizing that all the other so called P-Con evidence is just as forced and absurd! The challenges for you Dhira Govinda, is to explain all this smoke and mirrors and prove that *Photophobia is a symptom of cadmium and arsenic poisoning*. If you are a man of integrity, the alternative is to admit

you are a victim of a very compelling Svengali trance and stop perpetuating this unfounded nonsense!

5.3 **Sitapati Follow up NOTE:**

Although it was evident that Sitapati had been deceived by P-Con propaganda, I appreciated how he did not blindly accept the well-practiced mechanical answers Dhira Govinda gave when he interviewed him. He was astute enough to notice that the timeline of events impeached the damning allegations of the so-called whisper evidence.

- 1:50:13 Sitapati Dasa: I would like to push back on that,... I can't hear the claimed statements in the audio myself... the poison is going down, put the poison in the milk, why would they be saying that like in the room while they are talking about the poison?
- 1:50:57 Dhira Govinda: *it's NOT making sense to you* that they would talk about that...?
- 1:51:03 Sitapati Dasa: Yea, It seems to me the correlation of the time and the topic, would corollate...
- 1:51:16 Sitapati Dasa: ...where as the idea that there is a criminal conspiracy and they are literally whispering what they are doing it's like if you wanted to ever get busted for doing that you talk about it while people are thinking about it.
- 1:52:05 Sitapati Dasa: Has there been analysis of other indistinct whispers in conversations in vrindaban in 1977..in the last month? ..outside of those conversations?
- 1:52:34 Dhira Govinda: DG (does not know how to respond, he stalls and glorifies Truth Labs & blusters: "they analyzed many conversations...not just these 23 minutes" but he does not tell us what those conversations were. ... He does a lot of bluffing, diversion tactics, deferrals to Naveen Krishna, and as he attempt to regain credibility, the veneer of his façade starts to crumble.)
- 1:53:10 Sitapati Dasa: For me the jury is out on this one... that's where I am standing on that one.

For this reason I contacted Sitapati proposing that he do a podcast with me so his audience could be more aware of your hyperbole and inconsistent assertions. I was quite pleased when he responded:

"We'd be happy to have a conversation with you on the podcast." - March 24, 2025

Later Sitapati requested via facebook:

"If you want to make a claim that there is another interpretation of what Srila Prabhupada said, then I would want to examine the substance of that claim. Rather than simply saying: 'Well other people say there is different interpretation. Next!' OK, let's see what that interpretation is."

My response to that request was to listen very carefully to the March 25th podcast he produced and respond to him on April 18, 2025. I informed him that his message inspired me to write the article now published on my website. "Calling the P-Con Bluff" (http://jagannatha.com/calling-the-poison-conspiracy-bluff/)

I waited two weeks for a response then resent a duplicate email on April 24, requesting Sitapati to at least acknowledge receipt of my prior email. I got the impression we would be scheduling a date for the podcase he had said he would be happy to have but he didn't respond to that either. As I paid more attention to the material he subsequently posted on Facebook, it became evident he wasn't as serious about uncovering the truth about the P-Con fraud as I originally gave him credit for. He too had fallen into the contagious Svengali P-Con stupor and appeared to be very comfortable with staying possessed by that trance to some degree.

Staged Humility

6.1 Incompatible Behavior

You portray yourself as a humble servant requesting a fair chance for the concerns you have about Srila Prabhpada's final pastimes to be head, yet you the repeatedly fail to behave in a way that is consistent with that request. You claim to have read **DECEPTION** quite thoroughly:

"Again, I have read your Venom of **DECEPTION** cover to cover, including the section entitled 'What

Yet your 14 page critique makes absolutely no attempt to answer the specific questions addressed in Chapter 11: "Why So Much P-Con **DECEPTION**?" That chapter includes sub-section:11.6.2 "Important Questions Deserve Coherent Answers." These sections provide evidence indicating there is no possible way Srila Prabhupada was poisoned but they also provide you a chance to respond with appropriate counter evidence. This would be required if we met in a court room which, Nico deceitfully boasts he is prepared for: 26

"Nevertheless, we proceed cautiously, careful not to make mistaken accusations in a litigious world without being prepared to defend them in court." ²⁷ -SPHG Chapter168, Paragraph 1

So, why do you avoid the excellent opportunity to plea your case, convince others about the merits of your poisoning allegations by providing good answers to these relevant questions? Instead you chose to just rehash the same absurd, unfounded, and contrived, fantasy world, speculations, Nico uses to fool the gullible. When you avoid answering relevant facts related to the P-Con the implication is you have no good answers to defend the ugly allegations that have been made! This is the reason why the mass majority of devotees do not give any credibility to what amounts to no more than the hallucinations of a bitter, psychotic, eccentric.

Those personally present when Srila Prabhupada departed are well aware of the allegations that have been made and, with the exception of just a very rare few, they universally agree the P-Con is the biggest fraud ever conceived of in Vaishnava history. The conditioning you are subservient to explains why you proudly announce your humility but if you were humble you would realize how you have fallen hook-line-&-sinker for the P-Con Ruse and stop promoting it!

6.2 No Show? You Lose! Strike One!

On page 10 of your bombastic article announcing the premier to the IFSPF-Fibsite you requested:

"We ask that the ISKCON GBC Executive Committee acknowledges receipt of this letter and packet before October 2nd, 2024, and responds to this letter before November 1st, 2024. We request that you, the GBC Executive Committee, cooperate with the efforts of the Justice for Srila Prabhupada Foundation towards uncovering and revealing to Srila Prabhupada's followers and the world the facts regarding Srila Prabhupada's disappearance pastime. Please let us know before Nov. 1, 2024, whether you, the members of the GBC Executive Committee, are ready to meet and discuss with our team about the subject of this letter and future course of action related to the contents of this letter." 28

You complain that nobody has taking your P-Con concerns seriously and allege that the details about Srila Prabhupadas disappearance have been intentionally concealed.

"Truth about events surrounding **Srila Prabhupada's disappearance have been concealed,** and thus we can appreciate the efforts to reveal them, if not exhaustively, at least

thoroughly and comprehensively... While there are more details to emerge, Nico's book provides a clear picture of what happened." – Dhira Govinda, KGBG p22

Well, I spent over three years taking the P-Con allegations seriously and presented my independent findings which you just brushed aside as irrelevant because I am not career toxicologist. It is the P-Con-Fraudsters who have the reputation for spewing their deceptive spam everywhere while they continue to avoid any form of a civil dialogue to objectively study the facts. The way the P-Com has evolved is by spreading unchecked propaganda wherever it can and then censoring/ignoring any evidence that does not support it. Like most ISKCON-Basher-Fib-Sites, the IFSPF follows that same repressive style of unilateral communication. We pontificate... you listen and accept. No questions will be accepted and no opposition will be tolerated!

6.3 Villainous Avoidance

What makes all of this ever more villainous and revealing is the fact that for nearly five years there has been an open forum where anyone can post whatever they want about the P-Con, pro-or-con without it being censored! On February 13, 2021 Bhakti Vikasa's created a site specifically for the purpose of hosting an open honest exchange and he invited anyone who was interested to participate while the public could observe. A link to that URL has been advertised on the home page of AKINCHANA.NET website since then. It even reassures the cowardly that they need not provide their name to voice their opinion!

Only ONE anonymous individual had the temerity to post something, but you, Nico, Naveen and all the other P-Con loud mouths never made any effort to present your case! This site offered all of you an excellent chance to "...provide a clear picture of what happened..." so why didn't you do that? Ksatria code is that when challenged, if you do not show up, you automatically lose. This policy is still practiced in sports competitions, and in the courtroom today. Your failure to plead you case in a neutral environment is the reason why no civilized person takes the P-Con seriously! When invited to make your case the biggest P-con braggarts run away and hide!²⁹

If your agenda is to find out what led up to Srila Prabhupada's disappearance, then why didn't any of you jump at this opportunity to be heard? There is a monumental difference between the AKINCHANA.NET website and the IFSPF-Fib-Site. The first welcomes everyone to post what they like and does not censor entries whereas the IFSPF petition for like-minded individuals to join their efforts but does no tolerate any challenges to what they blindly allege! The concluding point is that for nearly five years, a neutral place was offered for you to speak your peace, but nobody representing the P-Con-Dark-Side showed up to be heard! Strike One.

6.4 Invitation to Truth Summit Meeting... Refused! Strike Two!

Shortly after IFSPF-Fib-Site published their ultimatum to be heard, Garuda Prabhu personally contacted both you and Naveen Krishna to attend a "Truth Summit" meeting he proposed to host in February of 2025 at Alachua. His plan was to allocate two full days in a university like forum with a cordial atmosphere, that even included prasadam. He proposed a neutral setting arbitrated by non-devotee professionals trained in mediation to review all the available evidence. The plan was to objectively study, evaluate, and carefully consider the full spectrum of available facts for the purpose of finally putting this quarter century battle to rest once and for all. He even arranged for a professional video staff to document the entire Truth Summit and record the proceedings for the public to view at a later date.

It is easy to make up numerous excuses for not posting anything on the open forum Akinchana website,

but this time Garuda made a very deliberate effort to create the ideal environment to honestly review everything about the P-Con that could possibly be arranged at NO COST TO YOU! Knowing that all the involved parties were busy people, Garuda had the foresight to suggest a date three months out so everyone could get it on their calendar with the least disruption. WoW! What a great proposal! This was an ideal opportunity for you to put everything on the table where you could fully expose whatever you felt had been suppressed or concealed by the GBC. Garuda made it clear that the event was to provide you an opportunity to appeal to the entire Vaishna community, and all you had to do was to settle on a date when you could attend. What more could a whistle blower ask for?

Yet despite this magnanimous effort, both you and Naveen always found some trivial excuse for why you could not addend. Behavioral Therapists, of which you are one, know that when something is important enough... people will show up for it even if they have to swim through shark infested water to do so. YOU, with a PHD in Behavioral Therapy know this very well and yet all you could muster is a litany of 25¢ excuses not to attend! Strike Two!

6.5 **Neither Vital or New!**

The IFSPF is a travesty of false advertising and it raises serious questions about your own mental health! The first article posted on the premier introduction of this site has the sensational headline: "Vital New Information that Srila Prabhupada was "Assassinated" by His Caregivers" OK... but what is that *New & Vital* information you are boasting about?

In that introductory 10 page editorial you present two documents Naveen Krishna contracted Truth Labs Forensic Services³⁰ to provide.

- 1. A 22 minute, "follow-the-bouncing-ball," video analysis of BBT audio recordings.
- 2. A "Salient Features" affidavit from Truth Labs

You present these documents to support your believe that the GBC conspired to murder Srila Prabhupada and you share them enthusiastically with the Vaishnava community. But it took five years for Truth Labs to release these documents! Why did it take so long when they boast on their website how they can meet the fast pace of a courtroom and can prepare evidence in less than two months?³²

Upon scrutiny, we discover that Truth Labs did not contribute anything *New or Vital* to convince a rational individual that Srila Prabhupada was poisoned! Naveen simply paid them to repackage the same-old, bad, contrived evidence to make it appear more credible!33

All they did with the controversial BBT audio tapes was clean them up and make it easier for children to follow what was clearly said or allegedly discovered leaking from the audio shadows! Truth Labs added captions to highlight the words as they were spoken so even a deaf person could be effectively misled! For historians and those wishing to confirm this point a comprehensive breakdown of that tape is available in the study called "22 Minute Autio Tape."³⁴

do any of their own research! They just did what they were paid to do. This explains why it took Naveen five years³⁶ to persuade these technicians to deliver what he contracted them to provide!³⁷

When the "Salient Features" affidavit from Truth Labs, is closely studied we discover just how sloppy, unprofessional and bias this document is. They make absolutely NO effort to address the most pivotal questions pertaining to the P-Con³⁹ which isn't really their fault, because Naveen did not hire them to do that!

rare cases of cadmium poisoning prior to 1977 as a response but such examples do not address the pivotal question. How could Tamal Krishna Goswami know what he was doing in 1977 when the medical industry clearly reports they were very uncertain about how cadmium affected the body 36 years later!

- **1970-1975** Cadmium is found in the topsoil of a Village in Shipham, Somerset, England. It was determined that high levels of cadmium were found in earth left there from Roman zinc mining efforts. Residents panicked and environmental agencies were called in to determine if it was save to live and grown vegetables in Shipham
- **1979** The National Archives issued a document titled "Investigation into cadmium contamination of soil and vegetables at Shipham, Somerset", reference MAF 461/85 (FCN 322). The document covers the period 1979-1980 and is one of the first studies done that address the medical impact cadmium can have on the body. A health study of the exposed population in Shipham (548 people) compared with a control population found no significant adverse health effects (once corrected for age, sex, etc.), despite the elevated exposure.

7.4 NO Relevant Cadmium Poisoning History!

- k. ... he specifically said: "DO NOT RULE out the possibility of EXTERNAL CONTAMINATION It should also be pointed out:
- A. Dr. Morris should have been consulted prior to jumping to the conclusion that his reports "Prove" intentional murder!
- B. This was the first time MURR equipment was used to analyze hair.
- C. The samples Dr. Morris received were 1/80th the normally required size.
- D. The NAA process is lauded for analyzing samples without destroying them.
- E. After the report was issued, Nico reports that the samples were destroyed!?

- F. NO explanation has been provided for why the samples were destroyed or lost!
- G. Dr. Morris's was under a gag order to communicate exclusively with Nico and nobody else. 

Krsna has given you badly needed valuable talents but you run the risk of losing it all if you continue to blaspheme Vaishnavas which you remail in is gross denial about and flagrantly disregard:

"Some people assume that it is not an offence to criticize a sādhu who has engaged in an objectionable activity, because one is only stating facts. But Śrīla Śrīdhara Svāmīpāda has written in his commentary on the 208 Third Shower of Nectar — Text 2a Śrīmad-Bhāgavatam, "nindanam doṣa-kīrtanam — whether the criticism is based on fact or not, the vocalization of a saintly person's faults is nonetheless counted as nindā (blasphemy)." -Narrotam Dasa Thakura, Madhurya-Kadambani, Third Wave, p. 208.

You can save yourself from the Mad Elephant offence and the disgraceful reputation you are getting from the aggressive opinionated insults you are publishing on the IFSPF-Fib-Site with a long overdue maya-culpa. There is no shame in acknowledging how your intellect has been severely crippled by years of associating with the misfit Nico. Doing so would be very self-redeeming and what a truly honest individual would do to break the tiger-tooth Svengali Trance you have been bitten by!

However, I almost immediately discovered that this just disingenuous posturing to gain credibility. The evidence was pouring out everywhere that Nico would misrepresent any facts that did not support his world-attention-getting P-Con-Script. It rapidly became very clear that I had to check virtually everything he presents because 50% of the time it is either taken out of context, wrong, or fabricated to suit the story he was telling. The **DECEPTION** was so ubiquitous it became apparent that would be the title for my book! The name emerged from repeatedly uncovering numerous examples of intentional DISHONESTY used for the very purpose of trying to prove an impossible crime that was committed!

The unfounded prejudice you have expressed towards me doesn't negate the relevance of the facts I have established. In a futile attempt to avoid addressing these essential points you have resorted to cheap, ad hominin attacks. Everyone knows that dismissing others with snarly insults is what losers do when they cannot defend their beliefs. You began that campaign in your letter to me dated October 24, 2021.

"... as far as I can perceive, the ISKCON Governing Body Commission doesn't consider your book to be an effective attempt to counter the allegations that Srila Prabhupada was given poison by persons with venomous motivations. Four months later the ISKCON India Scholars Board released a similar endorsement fully acknowledging the validity of the research I did and the idiocy that proponents of the P-Con fraud continue to deny and express today:

Moreover, Mayesvara Dasa, a direct disciple of Srila Prabhupada, has authored a comprehensive book rebutting the poison conspiracy. The book's title is **DECEPTION** (2019), and a key argument in his work is the historical improbability of the claim, noting that in the 1970s, cadmium—a heavy metal allegedly used—was not known at the time to have been used in any deliberate poisoning cases worldwide. The notion that Prabhupada's young attendants possessed the knowledge or means to employ such an obscure method is absurd, as Mayesvara demonstrates. Those interested in a deeper exploration of this controversy may request a copy of Mayesvara's book for further details.

In the spring of this year (2025) you attempt to embarrass the GBC for even referring to my work by pointing out that I lack specific credentials.

"Moreover, the GBC's reliance on the book **DECEPTION** (2020) by Mayesvara Dasa as a credible source is wholly misguided and, frankly, absurd. **Mayesvara Dasa possesses no qualifications as a forensic expert, crime investigator, legal professional, or prosecutor.** His commentary lacks both scientific and legal foundation, and his involvement represents yet another attempt by the GBC to mislead devotees and suppress a thorough and impartial investigation into the alleged poisoning of Srila Prabhupada."

Releasing a statement like this makes you appear very uninformed, literate and desperate. **Steve Jobs** (Apple), **Bill Gates** (Microsoft), **Mark Zuckerberg** (Facebook/Meta), **Michael Dell** (Dell Computers) & **Larry Ellison** (Oracle) all dropped out of college and are far more successful then you. Would you be as quick to characterize them a not credible sources also?

When Druta Karma published Forbidden Archaeology in 1993 he exposed the fraud committed by pale-ontologists who were on a mission to establish evolution as a scientific fact using fossils. 10.2 Advance Degree Not Required to Spot Buffoonery!

Over 100 billion US dollars are spent annually on vitamin supplements by people who have little or no formal training in medicine. There is also a huge market for organically grown foods because a PHD is not required to understand the need to eat healthy, nutritious foods not contaminated with pesticides. One does not need a formal education to understand that food poisoning often leads to nausea, violent stomach cramps, and in severe cases vomiting.

Similarly, just a little basic biology is all it takes for an objective layman to understand that Srila Prabhupada could not have been poisoned by Cadmium as alleged. This fact alone confirms that those promoting the P-Con are committed to causing as much havoc as they can to Lord Caitanya's IS-KCON branch of the sankirtana movement. If they are not aware of that then they have no common sense and are complete buffoons!

10.2.1 Cadmium Sankya

P-Con advocates are quite smug about claiming that 250X what is normal levels of cadmium was allegely found in Srila Prabhupada's hair and is irrefutable scientific proof that he was maliciously poisoned:

"Average normal cadmium level in human hair is 0.064 ppm. Srila Prabhupada's 15.73 ppm cadmium average in 3 tests is about 250 X normal... 10 These levels of average 15.73 ppm cadmium in hair could only come about by a deliberate, malicious, homicidal poisoning through food or drink, via cadmium salts which are water soluble, tasteless, colorless, and look like Sugar." – Wednesday, December 4th, 2024, https://justiceforsrilaprabhupadafoundation.org/vlogs/

This is convincing propaganda to those who have absolutely NO understanding of what happens to food after it is swallowed⁵⁹ and enters into the gastrointestinal tract.⁶⁰ For the ignorant P-Con'ers in that category we will explain what that process is when someone ingests cadmium.

After it enters the esophagus, is proceeds to the stomach were 90-95% of it just passes thru the body and is eliminated in the feces fairly quickly. The little that is left enters the bloodstream which gets passed thru the kidney that then starts filtering it out as an impurity. Those impurities are routed to the bladder where they get excreted in the urine within 24 hours. Meanwhile the blood also passes thru the liver where it metabolized (neutralizes toxicity) foreign matter (the cadmium) found in the blood. This means that the hair only gets exposed to an extremely tiny portion of the cadmium originally consumed for just a few hours after it is ingested.

10.2.2 The Science

It is not fair, logical, or honest for you to dismiss that which you do not understand. This is the chemical/biological formula required to achieve a concentration of cadmium 250 times higher in the hair, then what is "Normal" $\{0.5 \, (\mu g/g)\}$. The calculation is:

 $0.5 \mu g/g \times 250 = 125 \mu g/g 0.5$ \, \mu g/g \times 250 = 125 \, \mu g/g

If you did this math, then please provide it to show how it supports your statement: "These levels of...cadmium... could only come about by a deliberate, malicious, homicidal poisoning"

If you have NOT completed the calculation, then it appears once again that you are blindly repeating what others have said without first confirming if it is true,.. and in this case even possible! This is where the help of an expert witness can assist us in understanding:

"What would be the cadmium prescription Srila Prabhupad would have to follow for his hair to retain 250X more cadmium deposits in his hair than is normal?

Where all of this gets very technical is the fact that our bodies are NOT all the same. Therefore, the calculations necessary to answer this question requires that we assign averages to the influencing variables before we can do the math and get a ballpark answer to this most important question! Therefore we will complete the math using the following average assumptions:

- 1. Normal Cadmium Levels in Hair: 0.5 micrograms per gram (µg/g)
- 2. Target Cadmium Levels: 0.5 X 250 = 125 \mu g/g
- 3. Average gastrointestinal absorption rate of cadmium: 5%.
- 4. Excretion Rate: Very slow biological half-life 10-30 years. (Assumed negligible.)
- 5. Hair Mass: Between 100 grams to 150 grams. We'll use 125 grams.

After applying these assumptions the calculation can now be made:

What the science of chemistry and biology tells us is the hair would have to be exposed to 312.5 milligrams of cadmium for it to absorb levels 250 X more then what is commonly found in the average person's hair! We have already established that if someone were to simply swallow 312.5 milligrams of cadmium, 95% of it (296.9 mg) most of it would just pass right out of the body and only 15.6mg would enter the blood stream. The kidney and liver would then start the process of removing it from the blood. An expert toxicologist would intervein at this juncture to inform us that ingesting even 50–100 mg of cadmium chloride would be acutely toxic and be considered a medical emergency that could lead to immediate death!

So with this understanding, how could Srila Prabhupada's hair ever accumulate such abnormal amounts of cadmium as alleged by the P-Con-Prophets?

10.3 Another Smoking Gun Backfire!

A toxicologist would confirm that for hair to accumulate 250 X normal cadmium levels in the hair, the blood would have to deliver it, non-stop, at very high levels for a prolonged period. Depending on the specific values that we used to complete our calculation it is estimated that Srila Prabhupada would have had to drink 12 oz tumblers of milk laced with a massive amount of cadmium every 24 hours for as much as a year! Yet the P-Con story is:

"...a prolonged ingestion of small amounts of cadmium" 61

Srila Prabhupadas personal nurse Abhirama prabhu testified⁶² that on the rare, intermittent occasions

when Srila Prabhupada could consume anything, it was just a few teaspoons of milk fed to him like a mother feeding their baby child!

Even a prime fit young man could not endure the vigorous routine required to deposit such large volumes of cadmium in his hair for even a week without going into convulsions! The purveyors of the P-Con have triumphantly pranced around telling the world that the high cadmium levels scientifically proves their allegations,... and indeed it does! But what they scientifically proves is how their allegations are not even possible! Even Nico admits that there has never been any study done showing such high reading of cadmium in anyone's hair ever before!

(21) No studies were found with living subject's hair having anywhere near 16 ppm. ⁶³
