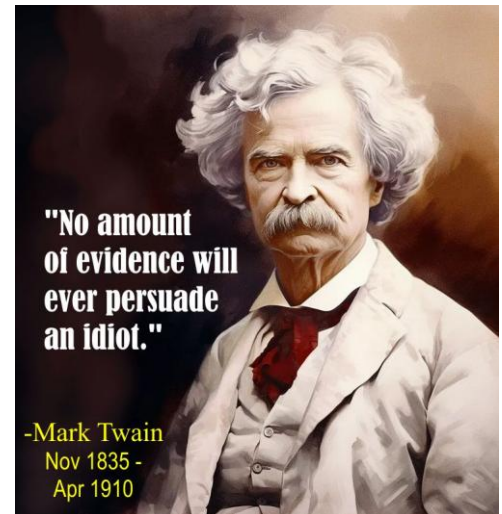
You are fully entitled to think the way you do & it would not be right to try to make you agree if you are not convinced. Haribol, all glories to Srila Prabhupada.
